

APPENDIX 14 - PREMIER TIER PLAYOFFS DOCUMENT

PUBLISHED | 11 April 2025 (V6)

This document specifies the playoffs which would be required to decide which team(s) will compete in the Premier Tier leagues for the 2025-26 season. This document should be read in conjunction with [REG 8, Appendix 10](#) and the relevant [sport specific regulations](#).

FORMAT OF PLAYOFF FIXTURES

The format of each playoff is determined by the number of eligible teams and the number of positions available in each league. The notes accompanying each playoff outline how the 'winning' team(s) is/are determined, number of promotion spots available, and how the playoffs have been drawn.

All teams who may be eligible to compete in playoffs are listed in this document, this includes teams finishing in 'potential' playoff spots in [Appendix 10](#).

All playoff fixtures must be played in accordance with the requirements of the tier of competition to which teams are seeking promotion, for example National league general and sport specific regulations ([REG 8.3.8.5.2](#)).

Please see [REG 8.3.8.5.3-8.3.8.5.5](#) for clarity on which matches must be played to the end of 'normal time' only and which may also require specific tiebreaker penalties to take place.

DEADLINE FOR COMPLETING PLAYOFF FIXTURES

Please see [Appendix 2a](#) for the playoff deadlines for all sports. It is requested that institutions are as accommodating as possible when (re)arranging playoff fixtures to allow fixtures to be completed by this date. Any alterations to the scheduled dates listed must be by mutual agreement in writing between the institutions involved and approved by the BUCS Executive before being updated on BUCS Play. **Any fixtures remaining unfulfilled after the playoff deadline will be resolved at the discretion of the BUCS Executive.**

WITHDRAWAL FROM PLAYOFFS (ELIGIBLE AND POTENTIAL TEAMS)

If an eligible or potential playoff team wishes to withdraw from the playoffs, they must do this before **23:59 on Tuesday 18 March**. We would encourage institutions to withdraw teams they think could potentially be involved in the playoffs as soon as possible. To withdraw please send an email to the [BUCS Competitions Team](#). Teams not withdrawn prior to the deadline shall be subject to honouring all scheduled fixtures ([REG 8.3.8.5.1](#)), if they do not they shall be liable to conceding walkovers and so may face sanctions in in with [REG 13.7.5.3](#).

Any team that wishes to be involved in the playoffs should ensure that if they were to secure a place in a specific Premier Tier league that they would be able to meet the regulations and requirements of that league and any associated knockout competition.
