



FISU Summer World University GAMES 2025

Taekwondo

The FISU Summer World University Games will take place across the Rhine-Ruhr region of Germany with competition dates across the 16 July 2025 to 27 July 2025.

British Universities and Colleges Sport (BUCS) is sanctioning a GB Students delegation as National University Sports Federation (NUSF) to represent the United Kingdom of Great Britain and Northern Ireland. The GB Students delegation is anticipated to arrive at the official entry point of Dusseldorf Airport in accordance with the official arrival and departure dates for sporting disciplines.

Athlete Arrivals

All athletes must activate their accreditation card at least 48 hours before their first competition. Athletes arriving late might not be accredited on time for the General Technical Meeting/Draw of their competition and therefore might not be allowed to compete following the rules of the concerned sports.

Nominations

All athletes who wish to be considered for selection must submit an online registration on the [BUCS website](#) by 11.59pm on 30 March 2025. All nominations will be open from Friday 28 February.

Any athlete who fails to complete the online registration and submit the supporting document (IANA form) by the deadline may not be considered for selection. Please note that this process will necessitate your university confirming your eligibility in writing on a template form, and this being received by BUCS by the stated deadline.

Selections

Selections will take place by **Friday 4 April 2025**.
Selected athletes will be notified by email **Friday 4 April 2025**

Athlete Costs

The cost of participation in this event will be in the region of £2000 - £2500 excluding flights and will be required in full at the point of selection. Athletes submitting a nomination acknowledge this requirement and accept financial liability including in the case of withdrawal related to injury or illness.

Anti-Doping

All athletes must complete the UKAD Complete Clean+ eLearning course and upload a copy of their course certificate upon nomination. The **Complete Clean+** eLearning can be accessed for free via the [UKAD Clean Sport Hub](#). Once registered, athletes can click onto the relevant eLearning and complete the modules at their convenience. *Complete Clean+ contains 11 modules which explore*



Anti-Doping topics including athletes' rights under the World Anti-Doping Code, UK Anti-Doping Rules, the Prohibited List, checking medications and supplements, the Testing Process and how to report concerns around doping in sport.

Eligibility Criteria

For an individual to be eligible to represent BUCS & GB Students they shall:

INT 1.1.1 Be a British (United Kingdom) national.

INT 1.1.2 Be a registered student at an institution which is a recognised provider of Higher Education (HE) proceeding towards a degree or diploma at the university or similar, the status of which is recognised by the appropriate national academic authority of their country (England, Scotland, Wales, Northern Ireland).

AND

INT 1.1.3 Be at least 18 and no older than 25 years of age on 31 December of the year of the event (i.e. born between 1 January 2000 and 31 December 2007). For 3x3 Wheelchair Basketball the age limit will be exceptionally extended allowing athletes at least 18 and no older than 28 years of age on 31 December of the year of the event (i.e. born between 1 January 1997 and 31 December 2007) to take part in it.

AND

INT 1.1.4 Be registered on a course which is at or above one of the following minimum levels:

- Level 4 on the Framework for higher education qualifications in England, Wales and Northern Ireland (FHEQ).
- Level 7 on the Scottish Credit and Qualifications Framework (SCQF).
- Level 4 on the Regulated Qualifications Framework for England and Northern Ireland (RQF).
- Level 4 on the Credit and Qualifications Framework for Wales (CQFW).

INT 1.1.4.1 An individual at an institution outside of the UK shall be registered on a course equivalent to those covered under INT 1.1.4.

AND

INT 1.1.5 Be undertaking a study programme equivalent to:

- Where the course is credit rated under CATS (Credit Accumulation and Transfer Scheme), at least 60 credits per year.
- Where the course is run using guided learning hours, a minimum of 225 hours per year.
- Where the course is a postgraduate course which is not credit rated, no less than 50% of the full-time student programme per year.

INT 1.1.5.1 A year will be taken as 12 months from the start date of their course.

INT 1.1.5.2 An individual at an institution outside of the UK shall be undertaking a study programme equivalent to the requirements of INT 1.1.5.



AND

INT 1.1.6 Be a player who is permitted by the International or National Governing Body of the sport concerned to participate in FISU competition alongside any other competition in that sport, which requires the athlete to:

- Hold a current World Taekwondo Global Athlete license;
- Hold a current and valid Kukkiwon certificate;
- Not be serving any current or pending suspension as a result of an anti-doping rule violation;
- Not be serving a current or pending suspension from either the GB Taekwondo performance programmes, or British Taekwondo membership as a consequence of misconduct, bringing the sport into disrepute or making false statements.

INT 1.2 Special cases for participation Further to any FISU regulations in place at the time, the following individuals are classified as eligible to represent BUCS & GB Students in FISU competitions:

INT 1.2.1 Notwithstanding INT 1.1.5, an individual who is otherwise eligible under INT 1.1 on a sandwich/industrial placement as part of their course is eligible during this time.

INT 1.2.2 A former student of an eligible institution (as per INT 1.1.2) who has obtained an eligible qualification (as per INT 1.1.4) from said institution in the calendar year preceding the event. For this event Students graduating in 2024 will be eligible to compete in 2025, as former students who have obtained their qualification in the calendar year preceding the event.

Please note that any athlete who is currently suspended or expelled by FISU, WADA, International or National Federation is ineligible for selection.



Sport Specific Regulations TAEKWONDO GENERAL TERMS

1.1. The Taekwondo events will be organised in accordance with the most recent technical regulations of the World Taekwondo (WT). In any dispute, the English text will be regarded as authoritative.

1.2. The programme and duration of the competitions are fixed by FISU in agreement with the Organising Committee. In principle, the programme will last seven days and include: Kyorugi Competition: - Individual Events Men Women Up to 54kg Up to 46kg +54kg to 58kg +46kg to 49kg +58kg to 63kg +49kg to 53kg +63kg to 68kg +53kg to 57kg +68kg to 74kg +57kg to 62kg +74kg to 80kg +62kg to 67kg +80kg to 87kg +67kg to 73kg +87kg +73kg - Team Events Men Women Tag Team Tag Team Mixed Tag Team Poomsae Competition: - Individual Events Men Women Individual Individual - Team Events Men Women 3 athletes' team 3 athletes' team Mixed team (pair)

1.3. Each delegation is authorised to enter: Kyorugi Competition: a maximum of 16 athletes (8 men and 8 women) - Individual events: a maximum of 1 athlete per weight category - Team event: a maximum of 1 male team, 1 female team and 1 mixed team Regulations for the FISU World

University Games 62 The Kyorugi team competition will be organised as follows: - Male and female team competition with 3 athletes per team per gender respectively; - Mixed team competition with 4 athletes (2 males and 2 females) per team. Teams shall be composed of athletes selected within the 16 Kyorugi and 10 Poomsae athletes of each participating delegation in accordance with the following total weight: - Male: The total weight of the 3 starting athletes should be 240kg or less. - Female: The total weight of the 3 starting athletes should be 200kg or less. - Mixed: The total weight of the 2 starting male athletes of each match should be 160kg or less. The total weight of the 2 starting female athletes of each match should be 135kg or less. Athletes are not allowed to participate in more than one Kyorugi team competition (i.e. if a male or female athlete is competing in the male or female team competition, he/she cannot participate in the mixed team competition to avoid any conflicts or delay). Poomsae Competition: a maximum of 10 athletes (5 men and 5 women) as follows: - Individual events: a maximum of 1 male and 1 female - Team event: a maximum of 1 team of 3 athletes per gender and 1 mixed pair - Each athlete shall perform a Recognized Poomsae and a Free Style Poomsae in the Final Round. - Allocation of Points (finals only): Recognised Poomsae (50%) and Free Style Poomsae (50%). Each athlete may compete in more than one category of the Poomsae competition. Each athlete may compete in both Kyorugi and Poomsae. All athletes must have a valid WT license. The license number must be properly indicated on the Individual Entry Form.

1.4. At the first General Technical Meeting, the Head of Delegation or their representative shall confirm and sign the official list of athletes. Any entry not duly confirmed at the first General Technical Meeting will not be taken into consideration except for force majeure. Only with an accreditation card approved by the CIC can an athlete be entitled to participate in any of the competitions.

2. PRE-COMPETITION PROCEDURE

2.1. Payment (cf. FISU Games General Regulations Art. 5.5.5) Two months before the opening ceremony of the FISU World University Games, all delegations participating in Taekwondo must confirm their participation with the payment of a deposit of EUR 425 per athlete and official registered



in the Quantitative Entry. The deposit shall be received by the Organising Committee and shall be credited to the remainder of the participation fees to be paid to the Organising Committee.

2.2. Seeding and Draw Drawing for Poomsae, Individual Kyorugi and Team Kyorugi shall be held immediately following the General Technical Meeting in the same location. Electronic drawing shall be organised by the OC under supervision of the FISU Technical Committee Chair. A certain number of athletes may be seeded based on their ranks in the WT world ranking, according to the guidelines stipulated in the by-laws of the WT world ranking. Regulations for the FISU World University Games 63.

2.3. Weigh-in The official weigh-in for each category will take place the day before the competition of that same category. Random weight-in will be conducted based upon WT rules at the competition venue.

3. TECHNICAL OFFICIALS

3.1. Nomination All international technical officials are nominated by WT and approved by the FISU Taekwondo Technical Committee Chair. These ITOs must be invited by the OC no less than three months before the opening ceremony of the FISU World University Games . The OC and the NF will appoint NTOs to complement the team of technical officials required for Taekwondo.

3.2. Number of Technical Officials There shall be 44 ITOs: - Kyorugi: 28 International Referees; - Poomsae: 16 International Referees. The number and the roles of the NTOs shall be agreed between the OC and FISU.

3.3. Arrival and departure days Unless otherwise stated by FISU, all international technical officials are to arrive one day prior to their first official meeting as agreed between FISU and the OC and depart one day after the end of competition.

3.4. Accommodation Unless otherwise stated by FISU, ITOs are to be accommodated in single rooms.

3.5. Financial obligations Participating teams must pay a contribution fee for the ITOs' costs to the Organising Committee in order to cover the cost (travel expenses, accommodation, full board and the per-diem) of the international referees from WT according to the pro-rata of athletes registered. The fixed contribution fee for the ITOs' costs is indicated in the General Regulations Article 5.5.9.

Poomsae Selection Criteria

Athletes will be selected for the Poomsae events at the World University Games based on the criteria below, and with the objective to select athletes that demonstrate the potential to be competitive in the pursuit of medal success.

Athletes who have achieved at least a 5th place in **both** a WT G-ranking 18-30 yrs old Recognised Poomsae event and a WT G-ranking 17+ Freestyle Poomsae event respectively (3rd+ place if 17-24x division entries in either discipline, 2nd+ place if 9-16 division entries for Recognised Poomsae/ 5-16 division entries for Freestyle Poomsae (n/a as a Recognised Poomsae selection criteria if <=8 division entries, n/a as a Freestyle poomsae selection criteria if <=4 division entries), with the results being recorded within 12 months of the date of the FISU competition.

Kyorugi Selection Criteria

Athletes will be selected for the individual Kyorugi events at the World University Games based on either Criteria A or Criteria B. In setting out these criteria, the objective is to select athletes that demonstrate the potential to compete for a medal. In the first selection round, athletes will be selected according to Criteria A. Once all weight groups have been considered per Criteria A, any weight groups where an athlete hasn't been selected will be reconsidered per Criteria B.

The selection panel will only consider entering athletes for the Kyorugi team event, where there is sufficient strength in depth, of athletes selected to the individual events, and where the weights of



selected individuals falls within the FISU criteria as set out above.

Criteria A:

For an athlete to be considered in Criteria A they will have delivered a strong performance resulting in making it to the semi-final in a senior category of at least one of the below events:

- Turkish Open – February 2025
- Dutch Open - March 2025
- Belgium Open - March 2025
- British Open – March 2025 (must reach the final of this event)

Criteria B:

For an athlete to be considered in Criteria B there must be clear evidence that they are on a trajectory towards success at future senior major championships. This will be evidenced by one or more of the following factors:

- Consistently improving competition performances across 2025
 - This will be measured by but not limited to the following areas; ability to score points and ability to win rounds
- Matches won against strong opposition
- Predicted physical fit into an Olympic weight category

Selection Panel Procedure

A. Selection Panel Members

The Selection Panel will consist of:

- The GBT Head of Teams & Operations (**non-voting**) who will act as the Chair of the Selection Panel;
- The GBT Head of Athlete Development (**voting**);
- A members of the GB Taekwondo coaching team (**voting**); and
- A representative of BUCS (**non-voting**)
 - (i) Attendance will normally be in person but, where this is not reasonably possible, attendance via telephone or other methods will be permitted;
 - (ii) The Panel Chair may, exceptionally, co-opt one or more additional voting members of the Selection Panel where this is necessary.

B. Selection Panel Procedures

-
- (i) The Panel Chair may allow the attendance of personal coaches, or others, where this is believed likely to assist it with a selection decision and, where this happens, will determine what reasonable requirements in relation to confidentiality and otherwise should be imposed. Any such attendees may be asked to leave when other athletes are being discussed, or at any other time, and will not be present when any vote takes place.
 - (ii) The Selection Panel may call for, and give appropriate weight to, any evidence they believe may assist them in their selection decision.
 - (iii) Where a vote is drawn, the Head of Athlete Development will have the responsibility to have the casting vote to conclude the selection decision.

- (iv) Any athlete refusing or failing to comply with a reasonable request made by the Selection Panel may be disqualified from further consideration for selection.
- (v) Each voting member will vote by writing the selection on a piece of paper and, without disclosing the selection to any other members of the Selection Panel, passing it to the Panel Chair who, when all the votes have been cast, will confirm and record the result. An appropriate equivalent procedure will be adopted in respect of any voting member who is taking part by telephone (e.g. they will state their selection once all other votes have been cast or in the alternative text or email their vote to the Procedural Adviser).
- (vi) Typewritten notes of each selection meeting will be prepared and circulated amongst members of the Selection Panel for agreement and will include, among other things, the reasons for all selection decisions made and the number of votes cast for or against each athlete considered.

C. Selection Panel Objectives

The Selection Panel's primary objective is to select the athletes who have the best chance to win the best set of medals at the Event.

Further, the Selection Panel:

- (i) Will determine in which weight division(s) to enter athletes, to achieve the best set of medals at the Event;
- (ii) May select an athlete at a higher and/or lower weight category where it is deemed that athlete will be more competitive than any other athlete who has registered an interest for the Event;.

D. Selection Panel Terms of Reference

In exercising their discretion, the Selection Panel will refer to the criteria set out above and may also give regard to the following factors:

- WT World Ranking List information
- Medals won
- Quality and quantity of matches
- Opponents fought
- Percentage of matches won/lost
- Consistency of results and performance at competitions
- Technical abilities
- Career performance/results in Major Championships
- Letters of commendation from personal coaches
- Any other relevant factors which the Selection Panel consider relevant for the Event

Selection Appeals Procedure

Introduction

1. The following Selection Appeal Procedure has been adopted by GB Taekwondo ("GBTKD") and governs all challenges made by an athlete, of any age or category, to a decision of GBTKD of selection, or non-selection, for the Great Britain Taekwondo Team.
2. Appeals against a selection decision are limited to athletes under consideration for that selection and are permitted solely on the grounds that the applicable Selection Procedure was not followed.
3. The Parties agree that any challenge to a selection decision shall be exclusively referred to and finally resolved by arbitration under this Appeal Procedure. The Appeal Panel shall apply English law in determining any dispute referred to arbitration under the Selection Appeal Procedure and the seat of the arbitration will be England. The Parties agree that the powers of the Courts are excluded (including, without prejudice to the generality of this provision, those powers under sections 44, 45, 69 and 79 of the Arbitration Act 1996) and shall not apply to any arbitration commenced under this Selection Appeal Procedure.
4. An athlete seeking to appeal against a selection or de-selection decision should be aware of the importance of the time limits contained in this Selection Appeal Procedure. These time limits are designed with the intention of resolving issues as expeditiously as reasonably possible, consistent with ensuring a fair and just outcome. Breach of any time limit will end the appeal process unless GBTKD have previously agreed to extend the time allowed. References to days include weekends and bank holidays. Where a deadline expires on a particular day, it will expire at midnight on that day.
5. Where an athlete is not selected or is de-selected, a brief written explanation, by e-mail or any other convenient means, for that non-selection or de-selection will normally be provided within 72 hours of any such decision. This document will be deemed to have been received by the athlete if (and when) it has been received at the most recent address notified by the athlete. This is so even if, in the case of e-mail, the e-mail address is displaying an "out of office" or similar notice.
6. Notice of Appeal from a selection or de-selection decision must be lodged in writing, within 4 days of the athlete being notified of this decision, in the manner outlined in clause 5 above, addressed to the Chair of GBTKD ("The Chair") at its registered office (which is at present Ten Acres Lane, Manchester M40 2SP) and accompanied by a cheque for £300 made payable to "Sport Taekwondo UK Limited", to be held by way of deposit towards the administrative costs of holding the appeal hearing ("the Appeal Fee"). The Notice of Appeal must specify the provision of the selection policy which it is alleged has not been adhered to, and a brief explanation. For athletes under the age of 18 years, a parent/guardian may lodge the appeal on their behalf.

The Involvement of Sport Resolutions (UK)

7. If the Chair determines that it is appropriate for the appeal to proceed, he/she will refer it to The Sports Dispute Resolution Panel Ltd, Company Number 3351039 (trading as "Sport Resolutions (UK)") who will appoint an independent sole arbitrator to determine the appeal ("the arbitrator"). The Chair shall determine, at his or her absolute discretion, whether the arbitrator will be instructed to determine the appeal on paper or whether it is appropriate for a hearing to be held. Either way, the decision of the sole arbitrator shall be final and binding on all concerned.
8. All selection appeals shall be governed by the Arbitration Act 1996 (save as expressly excluded above) and the Appeal Arbitration Rules of Sport Resolutions (UK) in force at the time of lodging the appeal ("the Sport Resolutions (UK) Rules"), save only as amended by the procedures set out in this document. Copies of the Sport Resolutions (UK) Rules will be provided on request or can be obtained directly from Sport Resolutions (UK). In the event of any conflict between the Sport Resolutions (UK) Rules and this Selection Appeals Procedure, the provisions in this Selection Appeals Procedure will prevail.

Variations to Sport Resolutions (UK) Rules

9. The Sport Resolutions (UK) Rules will be amended (in addition to those respects identified above) in the following ways:

(a) Time Limits

Time limits will be as set out below (and references to days include weekends and public holidays):

- (i) Notice of Appeal - identifying the specific part(s) of the Selection Procedure said to have been breached together with a brief explanation of the basis of the appeal – must be received by GBTKD within 4 days of notification of the selection/de-selection decision (as stated in clause 6 above);
- (ii) Statement of Appeal - containing all grounds of appeal, all facts relied upon in support of each ground of appeal, with copies of all relevant documents attached - must be received by GBTKD within 3 days of the expiry of the above time limit.
- (iii) GBTKD's Reply – containing all matters of response relied upon, with copies of all relevant documents attached—must be received by Sport Resolutions (UK), and a copy sent to the athlete, within 7 days of receipt of the Statement of Appeal.
- (iv) Communication of the decision by Sport Resolutions (UK) – within 14 days of receipt of the papers by Sport Resolutions (UK) (where the appeal is to be determined on paper), or within 7 days of the hearing (where there is a hearing), or such other period as The Chair may agree with Sport Resolutions (UK), having regard to the nature of the appeal, the matters at issue, the time available before the Event, the need for certainty amongst those affected by the decision, the ability of Sport Resolutions (UK) to comply with the time scale, and other relevant factors.
- (v) It is recognized that it is in the interests of the Parties to deal with any selection appeal expeditiously, and that all timescales set out above may be reduced where GBTKD reasonably believes this to be necessary or where GBTKD is subject to deadlines imposed by another party.

(b) Costs

No costs shall be awarded to either party, or each party shall be liable to Sport Resolutions (UK) for an equal share of the charges of Sport Resolutions (UK), save that:

- (i) The athlete shall be given credit against such charges for the Appeal Fee paid at the time of lodging the Notice of Appeal.
- (ii) GBTKD will pay the full charges of Sport Resolutions (UK) where the athlete's appeal is successful and may, at its discretion, also reimburse the Appeal Fee.

(c) Confidentiality

The Sport Resolutions (UK) Rules relating to confidentiality are adopted, and the appeal decisions will be published. The only exception to this will be where GBTKD is required to maintain the confidentiality of the selection by the British Olympic Association or any other organisation with involvement in the selection process, in which case publication of the decision will be delayed until GBTKD is at liberty to consent to its disclosure.

(d) Powers of the arbitrator appointed by Sport Resolutions (UK)

If the appeal is upheld, the arbitrator will quash the decision of the Selection Panel and remit the matter to the Selection Panel to make a fresh selection decision taking due account of any errors identified by the arbitrator in the original selection decision. For the avoidance of doubt, the arbitrator has no power of selection.

(e) Outcome

If the selection decision is quashed, the Selection Panel will meet within 7 days of GBTKD being notified of this to make a new selection decision and will inform the athlete of its decision within 24 hours of the new meeting. The decision of the Selection Panel at this stage will be final and binding, and no further appeal will be permitted.

If the Appeal is dismissed, the selection decision will be upheld and there will not be any further right of appeal.

(f) Amendments

Although GBTKD reserves the right to amend this procedure between events, it will not amend the selection appeal procedure published for a particular event unless compelling and unforeseen factors require this.

INT 1.1 Eligible participants Further to any FISU regulations in place at the time, for an individual to be eligible to represent BUCS & GB Students in FISU competitions they shall:

INT 1.1.1 Be a British (United Kingdom) national.

INT 1.1.2 Be a registered student at an institution which is a recognised provider of Higher Education (HE) proceeding towards a degree or diploma at the university or similar, the status of which is recognised by the appropriate national academic authority of their country (England, Scotland, Wales, Northern Ireland).

AND

INT 1.1.3 Be at least 18 and no older than 25 years of age on 31 December of the year of the event (i.e. born between 1 January 2000 and 31 December 2007). For 3x3 Wheelchair Basketball the age limit will be exceptionally extended allowing athletes at least 18 and no older than 28 years of age on 31 December of the year of the event (i.e. born between 1 January 1997 and 31 December 2007) to take part in it.

AND

INT 1.1.4 Be registered on a course which is at or above one of the following minimum levels:

- Level 4 on the Framework for higher education qualifications in England, Wales and Northern Ireland (FHEQ).
- Level 7 on the Scottish Credit and Qualifications Framework (SCQF).
- Level 4 on the Regulated Qualifications Framework for England and Northern Ireland (RQF).
- Level 4 on the Credit and Qualifications Framework for Wales (CQFW).

INT 1.1.4.1 An individual at an institution outside of the UK shall be registered on a course equivalent to those covered under INT 1.1.4.

AND

INT 1.1.5 Be undertaking a study programme equivalent to:

- Where the course is credit rated under CATS (Credit Accumulation and Transfer Scheme), at least 60 credits per year.
- Where the course is run using guided learning hours, a minimum of 225 hours per year.
- Where the course is a postgraduate course which is not credit rated, no less than 50% of the full-time student programme per year.

INT 1.1.5.1 A year will be taken as 12 months from the start date of their course.

INT 1.1.5.2 An individual at an institution outside of the UK shall be undertaking a study programme equivalent to the requirements of INT 1.1.5.

AND

INT 1.1.6 Be a player who is permitted by the International or National Governing Body of the sport concerned to participate in FISU competition alongside any other competition in that sport.

AND

INT 1.1.7 Meet the Sport Specific Eligibility Requirements as defined in the individual competition selection policy for that competition

INT 1.2 Special cases for participation Further to any FISU regulations in place at the time, the following individuals are classified as eligible to represent BUCS & GB Students in FISU competitions:



INT 1.2.1 Notwithstanding INT 1.1.5, an individual who is otherwise eligible under INT 1.1 on a sandwich/industrial placement as part of their course is eligible during this time.

INT 1.2.2 A former student of an eligible institution (as per INT 1.1.2) who has obtained an eligible qualification (as per INT 1.1.4) from said institution in the calendar year preceding the event.

INT 1.2.3 A student who would otherwise be eligible under INT 1.1. who has their studies suspended will not be eligible to compete until such a time as their studies recommence.

INT 1.3 Transgender athletes BUCS promotes a zero-tolerance approach to transphobia and any person or institution found to be in contravention of this regulation will face disciplinary action under REG 5.

INT 1.3.1 For FISU competitions, the policy on transgender participation of FISU and/or the International Federation whose sport specific regulations are being followed shall apply.

INT 1.3.2 Drug testing procedures and prohibitions, as outlined in INT 1.4, also apply to athletes who identify as transgender. Any athlete receiving treatment involving a Prohibited Substance or Method, as described on the World Anti-Doping Agency's Prohibited List, should apply for a standard Therapeutic Use Exemption.

INT 1.4 Anti-Doping All participants in FISU competitions are subject to the Anti-Doping rules of UK Anti-Doping (UKAD), the World Anti-Doping Agency (WADA), FISU, and the specific sport's International and/or National Governing Body. As such:

INT 1.4.1 All participants are subject to testing.

INT 1.4.2 Any individual who is serving a suspension as a result of an Anti-Doping rule violation will not be eligible to participate in any FISU competitions.

INT 1.5 Allowing ineligible participants to represent an institution will result in appropriate disciplinary action being taken. Athletic Union or equivalent staff should in cases of doubt refer the circumstances to the BUCS Sport Compliance and Governance Manager.
